1. Unacceptable behavior will not be tolerated, this includes but may not be limited to: bullying; fighting; violence; sexual activity; personal and/or on-going verbal abuse; use of profanity, use of alcohol, tobacco or illegal drugs; failure to follow safety guidelines; failure to follow directions of the organizers, Tribal departmental staff and chaperones; leaving the group/campsite without permission; and/or any act that may jeopardize the safety of your child or others.
2. Youth are required to participate in activities that are scheduled; cooperate with organizers, Tribal departmental staff and chaperones as well as other youth in attendance; Keep in mind that all children should be representing their Tribe in a positive and respectful manner.
3. Youth are prohibited to carry any electronic devices (examples: cell phones, ipod, and mp3) during the campout. The idea is to connect to the land and learn. Organizers, Tribal departmental staff, and chaperones will maintain cell phones during Campout except for times approved for use.
